<p>DECKING FLOORS AND UNDERFLOOR PROTECTION WMC 150.1E(b)(v) Provide all details for ignition-resistant construction of the deck including but not limited to decking, surfaces, stair treads, risers and landings.</p>			
<p>EXTERIOR COVERING WMC 150.1 E (b)(iii) & (ii) When the replacement of the exterior wall exceeds 80% of the exterior wall, the surface shall comply with the requirements of CWUIC 504.5. The exterior venting in this area shall comply with section CWUIC 504.5.</p>
