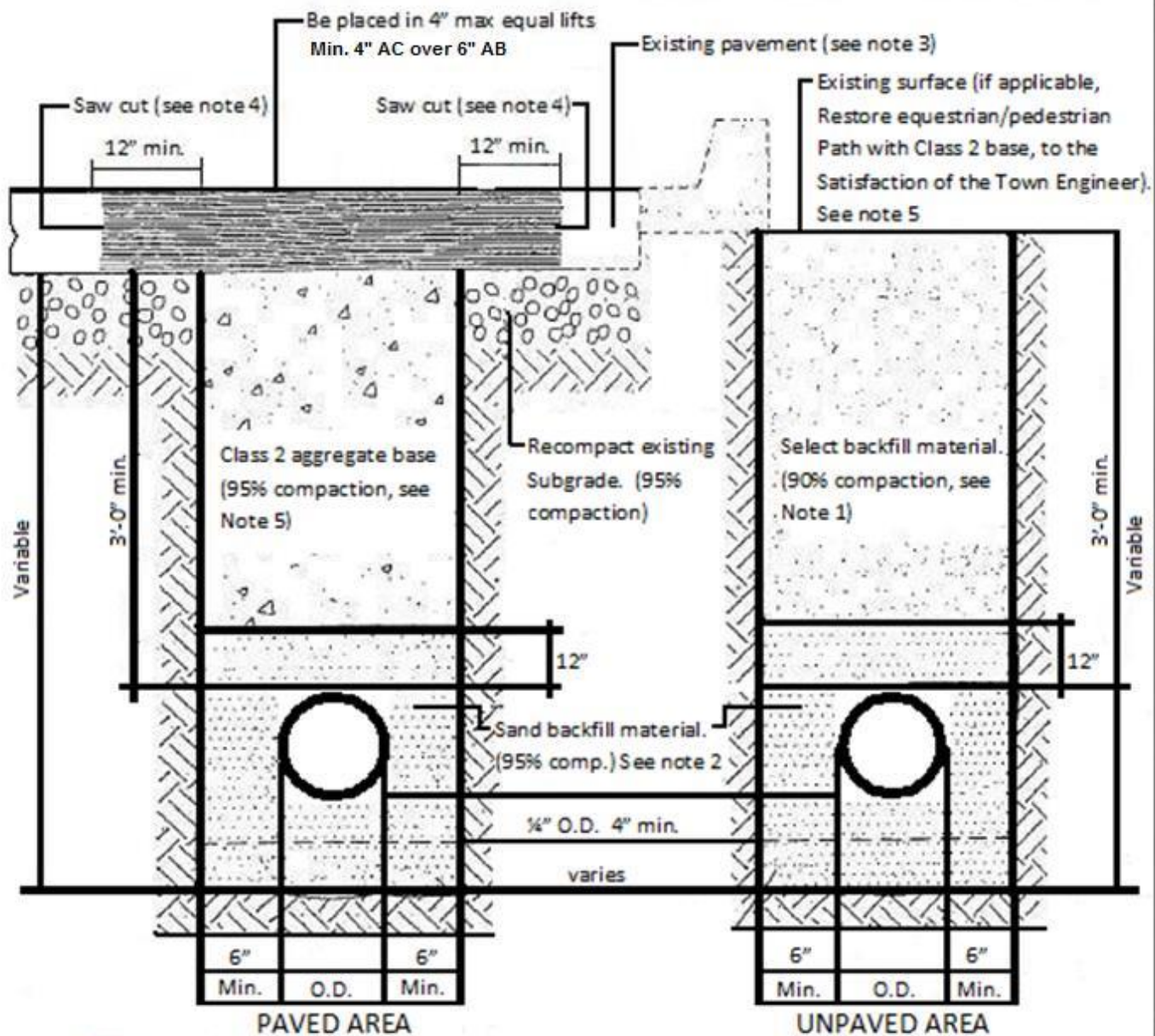

Applicant agrees to accomplish the described activity in accordance with applicable Town of Woodside codes, regulations, restrictions and specifications and to be subject to inspection and approval by Town Staff.

Notes:

1. Select backfill material. Material from excavation, free from stones or lumps exceeding 3" in greatest dimension, vegetable matter or other unsatisfactory material.
2. Sand backfill material. Material free from organic matter and clay with a sieve gradation by weight as follows:

Sieve Size	% Passing Sieve
No. 4	100
No. 200	0-5
3. If the edge of the trench falls within 3' of the gutter or shoulder edge, the entire pavement shall be removed.
4. It is recommended to saw cut after trench work is completed and backfilled.
5. Recycled Class 2 Aggregate Base.
